# What Illness Benefit for COVID-19 Absences is

If you are an employee or self-employed and feel you may have COVID-19, or may need to self-isolate as a result of COVID-19.

When a worker is told to self-isolate by a doctor or has been diagnosed with COVID-19 (Coronavirus) by a doctor, they can apply for an enhanced Illness Benefit payment of €305 per week

To be eligible for this payment a person must be confined to their home or a medical facility.

Do not visit your GP, contact them by telephone.

#### How to qualify

To receive the enhanced payment, you must be: self-isolating on the instruction of a doctor or other medical professional diagnosed with COVID-19 (Coronavirus)

#### Rates of payment

The personal rate for this payment is €305, as compared with the normal Illness Benefit rate of €203.

It will be paid for a maximum of 2 weeks where a person is self-isolating but will be paid for the duration of a person's absence from work if they have been diagnosed with COVID-19 (Coronavirus).

#### Conditions for Covid-19 Illness Benefit

Remember if you are applying for a COVID-19 Illness Benefit payment you:

- Must have been diagnosed with Covid19 or must satisfy the conditions for self-isolation specified in public health advice;
- Must be absent from work and confined to home or a treatment location
- Must not be performing any work
- Must have been in paid employment immediately prior to claim
- Must submit, on request, evidence of employment, earnings and absence from work

# For Employers and Small Businesses:

The Department of Business, Enterprise and Innovation have put a range of supports in place, including:

A €200m Strategic Banking Corporation of Ireland (SBCI) Working Capital scheme for eligible businesses impacted by COVID-19. Loans of up to €1.5m will be available at reduced rates, with up to the first €500,000 unsecured. Applications can be made through the SBCI website.

A €200m Package for Enterprise Supports including a Rescue and Restructuring Scheme available through Enterprise Ireland for vulnerable but viable firms that need to restructure or transform their business.

The maximum loan available from MicroFinance Ireland will be increased from €25,000 to €50,000 as an immediate measure to specifically deal with exceptional circumstances that microenterprises – (sole traders and firms with up to 9 employees) – are facing. Applications can be made through the MFI website or through your local LEO.

The Credit Guarantee Scheme will be available to COVID-19 impacted firms through the Pillar Banks. Loans of up to €1m will be available at terms of up to 7 years.

Minister Humphreys also highlighted the following supports for firms experiencing trading difficulties and short-term shocks:

The Department of Employment Affairs and Social Protection and the Department of Business, Enterprise and Innovation will provide a joint First Responder support service through the Intreo Offices and development agencies, Enterprise Ireland and IDA Ireland in each region to provide tailored supports for impacted firms, with objective of avoiding mass lay-offs and buying time for firms to work through the short-term disruptions.

Firms that need to reduce hours or days worked can avail of the Department of Employment Affairs and Social Protection Short Term Work Support by contacting their local Intreo Office, see gov. ie/en/service/c20e1b-short-time-work-support.

The full range of Enterprise Ireland, IDA Ireland, Local Enterprise Office and Údarás na Gaeltachta grant supports will be available to firms to help with strategies to innovate, diversify markets and supply chains and to improve competitiveness.
